I. GENERAL INFORMATION

Region: *WESTERN VISAYAS (Region VI)*

Province: *Iloilo*

Population (as of August 1, 2015; in thousands): 2,384

Income classification: 1st Class Province

Major economic activities: *Farming and fishing*

The Province of Iloilo lies in the southern and northeastern portion of Panay Island. It is bounded by the Province of Capiz and Jintotolo Channel in the north; Panay Gulf and Iloilo Strait in the south; Visayan Sea and Guimaras Strait in the East; and the Province of Antique in the west.

Iloilo comprises 42 municipalities with one highly urbanized city and a component city, further subdivided into 1901 barangays. There are five congressional districts encompassing all cities and towns.

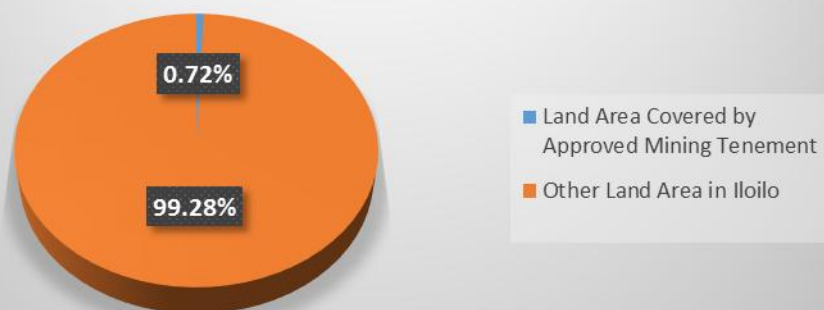
II. LAND AREA AND MINERAL POTENTIAL

Total land area of the province of Iloilo is 471,940 hectares. The total area covered by the approved mining rights is only 0.72% or 3,404.63 hectares of the total land area of Iloilo.

IV. ECONOMIC CONTRIBUTION

➤ Gross Regional Domestic Product (GRDP)

As shown in the table below, the three major industries contributing to the GDRP of Region VI in 2015 are agriculture and forestry which amounted to PhP 48,402,142 or 15.91%; other services (i.e., accommodation and food services, arts, entertainment and recreation services, etc) amounting to PhP 41,647,508 or 13.69%; and trade and repair of motor vehicles, motorcycle, personal and household goods amounting PhP 40,399,033 or 13.28%.

While looking at the Mining and Quarry Sector, the total production value of the region is PhP 6,447,868 or 2.12% of the GRDP in 2015. On a three-year record, the average production value of the Mining and Quarry Sector amounted to PhP 5,985,262.33. It has shown that the sector ranked second to the last among all other industries in the region.

GRDP is the aggregate of gross value added (GVA) of all resident producer units in the region. Addition of the GRDP of all regions will yield the Gross Domestic Product.
